



Website Design Agreement

This Website Design Agreement is intended to set forth the terms for this website design or re-design project. If these terms are acceptable to you, please sign below and return by scanning and emailing or by regular mail to Webati.

Website Package: Clients website will be developed to include the Package set forth on their order confirmation. All details and package specs can be found there. Should you have any questions you may also call us anytime.

Copyrights and Trademarks: The Client unconditionally guarantees that the text, graphics, photos, designs, trademarks, or other artwork furnished to Webati for inclusion on the web pages are owned by the Client, or that the Client has permission from the rightful owner to use each of these elements, and will hold harmless, protect, and defend Webati from any claim or suit arising from the use of such elements furnished by the Client. Copyright to the finished web pages produced by Webati is owned by Webati. Upon final payment, the Client is granted rights to use the website. Rights to the web design template such as PSD files, photos, graphics, source codes, software created to run the website, are not transferred to the Client; they remain the property of their respective owners. The Client may however, purchase the web design template (PSD files) at a negotiated price should client require them. Webati retains the right to display graphics and other Web design elements as examples of their work in their portfolio. Webati also retains the right to display a logo and/or text link on the bottom of all clients' web pages linking back to Webati website(s) unless agreed upon in a separate negotiated written release.

Fees: To begin working on your website payment is required. If you paid online, we will verify your payment and then start your work upon that verification. Webati reserves the right, without liability, to remove web pages from the Internet if outstanding balances are not paid. All payments must be made in USD and payable to Webati. Web hosting and domain name registrations are recurring fees. The Client agrees to reimburse Webati for 3rd party services such as web hosting, domain name registration, photographs or software based upon the clients request for usage

Website Content: The content of the web pages will be supplied by the Client. To include words of text supplied by the client at approximately 500-600 words per page maximum and must be supplied in an electronic format. Text of more than 600 words per page may be subject to additional fees. If no content is available, we can use printed materials such as a brochure or flyer to get started. Should the Client desire additional web pages beyond the original number agreed upon, the Client agrees to pay Webati for the web pages at the current rate of \$150.00 per additional page. Webati does offer professional copywriting as an additional service at \$150 per hour should client require copywriting.

Inspection and Testing: Although Webati strives for accuracy, unintentional errors may occur. The Client agrees to thoroughly proofread, inspect and test the web pages to ensure that the final product is to their satisfaction. Webati will not be held liable for any typos or omissions.

Internet Service: Webati does not guarantee that the Website will be uninterrupted or error-free. In no event will Webati be liable to the Client or any third party for any damages, including, but not limited to, service interruptions, the Hosting Service or any other circumstances beyond our reasonable control, any lost profits, lost savings or other incidental, consequential, punitive, or special damages arising out of the operation of or inability to operate this website, failure of any service provider, of any internet servers, you or your site visitor's computer or internet software.

Website Updates: Regular Website updates are **NOT** included, they are offered as an additional service. If client desires Webati can manage the updating of clients website. This can be added as an annual service should client require it.

Web Hosting: The client understands that any web hosting services require a separate contract with a web hosting service. The client agrees to select a web hosting service which allows Webati full access to the website hosting. The client can host their site with Webati for an additional monthly fee of \$37.

Assignment of Project: Webati reserves the right to assign subcontractors to this project to insure the right fit for the job as well as on-time completion.

Completion Date: Webati and the client must work together to complete the website in a timely manner. We agree to work expeditiously to complete the website as agreed upon.

Laws Affecting Electronic Commerce: From time to time governments enact laws and levy taxes and tariffs affecting Internet electronic commerce. The client agrees that the client is solely responsible for complying with such laws, taxes, and tariffs, and will hold harmless, protect, and defend Webati and its subcontractors from any claim, suit, penalty, tax, or tariff arising from the client's exercise of Internet electronic commerce.
